






Re: "Even one victim is one too many"—



At the suggestion of the Permanent Mission of Spain to the United Nations, Red T, a non-profit for the protection of T/Is in high-risk settings, was invited by the Permanent Mission of Switzerland to the United Nations to present at the December 2022 meeting of the Group of Friends for the Protection of Civilians (GoF PoC). On behalf of the world language community, we familiarized GoF PoC members with the lack of special protection for T/Is in situations of armed conflict and post-conflict peacebuilding and urged them to take up the matter.

Journalists and medical personnel benefit from the recognition UN resolutions bestow on them. In the case of translators and interpreters, this is even more critical because we are all too often mistrusted and persecuted. Thus, special recognition by the UN would usher in a paradigm shift in how we are perceived and treated – not as traitors but as impartial language facilitators who should not be attacked for our crucial function in high-risk arenas. In other words, a UN resolution could make a significant difference in the perception of our role, which, in turn, would save lives.
